Guarantee Contract-Terms and Conditions.

Please do not let this contract scare you in any way! I am always here for you and your puppy. I hope that you enjoy your new puppy for many years to come. I have taken every precaution to ensure that he or she arrives to your home healthy, happy, and pre-spoiled!

*****While reading this contract, you will initial each paragraph to show you have read and agree with each statement of this contract.**

1. A licensed veterinarian must examine the puppy within 72 hours of pickup or delivery. If the exam indicates that at the time of sale, the puppy was unfit for purchase due to illness, disease, or congenital disorder then the Buyer may return the puppy for an exchange of a puppy at equivalent value. If there are no other puppies available at that time you must wait for a puppy from a future litter. There will be **NO CASH OR CREDIT** refunds giving. We offer replacement puppies only. If you fail to have your puppy checked by a licensed veterinarian within 72 hours of pickup or delivery, we the seller, assume no further responsibility. The Buyer must have their veterinarian email the seller a report of the visit along with the form provided to the buyer before leaving the veterinarian office. The Seller's email is perkinsgentlegiants@gmail.com. The failure of this will result in the cancellation of this contract. (buyer's initials _____)

2. The Seller will have the puppy up to date on shots and worming on the date of purchase and Buyer will receive the puppy's health records for proof of this. I do Not guarantee color, sex, or what type of coat that your puppy has although I can give you my best educated guess. (buyer's initials _____)
3. The Seller will have provided, to the Buyer, AKC papers on their new puppy with limited registration at the time of pickup or delivery. (buyer's initials _____)
4. The Seller guarantees the puppy against fatal viruses for 72 hours after pickup or delivery. This includes Distemper, Parvo, and Corona. This does NOT include Coccidian, Giardia which are common in puppies and are usually caused by parasites or bacteria. It also does NOT include hernias, worms, hypoglycemia, and other minor illnesses. (buyer's initials _____)
5. The Buyer is aware and also agrees that they will NOT take the puppy into public places unless absolutely necessary, until the puppy has had all of its vaccinations (usually at 16 weeks of age, which then they will have received 3 sets of shots) This will insure immunity against diseases that can be found in doggy parks, pet stores, doggy potty areas, vet floors (be sure to hold your puppy at this time) and any other place that your puppy can contract a disease. (buyer's initials _____)
6. The Seller guarantees the puppy until one year of age, against fatal and **LIFE THREATING OR ALTERING** congenital and genetic defects which adversely affects the health of the puppy. This includes: Severe Hip Dysplasia which hampers a puppy's movement and natural gait plus will require surgery to correct. The Buyer also understands that Hip Dysplasia can also be caused by the following living conditions in the household or environment: Excessive use of stairs, vinyl flooring, hardwood flooring and other conditions that may be hard on the correct growing of the joints and bones. The seller has giving you information about how to protect your puppy in your puppy folder that was provided in your puppy packet. (buyer's initials _____)

7. The Buyer must notify the Seller of **Life Threatening** problems within two days of the licensed veterinarian's findings and have two reports from two different veterinarians stating the same problem. This includes Severe Luxating Patella's, Kidney, Heart, Pancreas, Spine, and Liver problems of a severe life Threatening or altering nature. If the puppy is proved to have a **LIFE Threatening** congenital defect within one year of the puppy's birthday it can be returned. The Seller will provide a replacement puppy of equivalent value when a puppy is available. The Buyer will be responsible for all shipping charges, if any occur, to return the puppy and to receive a new puppy. In the event the guarantee is exercised; the registration papers of the defected puppy must be signed and returned to the Seller. If local, on statement us come from the Seller Personal Veterinarian. (buyer's initials _____)

8. If the puppy dies within a one-year period, the Buyer must pay to have a necropsy done on the puppy to ascertain the cause of the unknown death. If the reason is genetic or congenital, the Seller will replace the puppy with an equivalent puppy. **NO CASH REFUNDS ARE GIVEN.** (buyer's initials _____)

9. The Buyer understands that there are certain disorders that may be caused by environmental factors, for example: allergies, thyroid dysfunctions, demodectic mange, and other autoimmune disorders that are not covered by this guarantee. Again, trauma to the hips are not covered by this contract but genetic defects are. (buyer's initials _____)

10. The Seller will NOT be responsible for any veterinarian fees, costs, or any fees with the shipping the puppy back to me. The Buyer is aware that owning a puppy means trips to the veterinarian and understands that they will be responsible for ALL payments after the purchase date. If for any reason this puppy must be returned. the Buyer is responsible for all shipping expenses. (buyer's initials _____)

11. The Buyer agrees to provide annual vet exams, including heartworm checks, preventatives and to finish the series of puppy vaccinations plus getting yearly boosters and keep all puppy needs up to date to ensure the health of the puppy.

The Buyer further warrants that the puppy will be kept in appropriate living conditions, fed, and water well for its health and welfare. (buyer's initials _____)

12. In the event of any litigation about this guarantee, the Buyer agrees for the dispute to be held in Franklin County, Illinois. (buyer's initials _____)

13. The Seller agrees to take the puppy/dog back at any age and at no cost if the Buyer can no longer keep it for any reason. If the Buyer wants to find a new home for the puppy/dog the Seller must first speak with the possible new owners of it and approve the home in which the Buyer is wanting to place it. The Buyer will sign all AKC paperwork over to the Seller at that time, AKC paperwork will not be giving to new owners of puppy/dog. (buyer's initials _____)

14. The Buyer agrees that **WILL NOT** take the puppy/dog to any shelters. (buyer's initials _____)
