



Spay/Neuter Agreement

Permanent ownership and receiving AKC registration papers of this dog is contingent upon your compliance with this Addendum. Proof of the spay/neuter must be received by within fourteen (14) days after the surgery. In the event that the dog's health does not allow this agreement to be honored, Perkins Gentle Giants must be provided with a statement from your veterinarian that this dog is not yet in physical or emotional condition for surgery. Based upon the veterinarian's evaluation of this dog the PURCHASER will contact the veterinarian and establish the earliest date that the procedure can be performed. The PURCHASER will notify the BREEDER of this amendment in writing, at which time all other conditions of this agreement will apply and be enforced.

****ONCE THE BREEDER RECEIVES THE PROOF OF SPAY/NEUTER FROM PURCHASER BREEDER WILL RELEASE AND SEND PURCHASER THE AKC REGISTRATION PAPERS WITHIN 3 BUSINESS DAYS****

This is the responsibility of the PURCHASER, not the veterinarian, to ensure that Perkins Gentle Giants has received verification that the surgery has been performed. Failure to comply with this agreement by the puppies age stated below, unless otherwise agreed to in writing, will be considered a breach of the Contract, and PURCHASER will transport this dog back to Perkins Gentle Giants and will not be entitled to a refund.

By my signature below, I agree to have this dog spayed/neutered by no later than 8 months of age or for a female before first heat cycle has taken place and I understand that this spay/neuter agreement is an agreement that this dog will not produce a litter of puppies either as purposely bred or by accidental breeding. I also agree that should puppy not be altered that I will return said puppy back to Perkins Gentle Giants with no refund. I understand that by voluntarily signing this agreement, I am entering into a

legal and binding contract with Perkins Gentle Giants. In the event there is a violation of the agreement, I agree to pay a minimum of \$2000.00 in damages. Additionally, to facilitate the collection of damages for breach of contract, I waive any challenge to venue and agree that the appropriate venue for this matter is the Commonwealth of Illinois, and the County of Franklin. Furthermore, I agree to accept service of process by certified mail, return receipt requested, to the address provided in this contract, and specifically waive any right to receive personal service.

I certify that I have read and understand the terms of this Spay/Neuter Agreement. I acknowledge that failure to comply with these terms shall be considered a breach of contract and shall result in the immediate return of the purchased pet to Perkins Gentle Giants and may result in civil penalties as set forth in the referenced sections of the Code of Illinois.
